The current rates per Patterson Code 158-4 (1) call for \$20.46 for the first 2,000 gallons per quarterly consumption, \$12.28 per 1,000 gallons in excess of 2,000, and a minimum monthly charge of \$20.46. The last rate increase was passed in May 2018 by Ordinance 466.
