Items discussed:

- Mr. Policaro requested that Chief Stanislawski provide a report regarding a
 request for police presence at 209 Darlington Road at the First Reform
 Presbyterian Church for a defrocking appeal hearing on Friday 12 April
 from 1pm -930pm and Saturday 13 April from 8:30 am- 1PM. Church has
 agreed to cover the cost of any overtime involved.
- Executive Session 6:15-6:45 to discuss personnel matters.
- Mr. Bradow stated he was revisiting the agreement with Chippewa Sewer Authority (Brady's Run Sanitary Authority) as the most recent agreement we have is from 1977. He is looking for a newer agreement with the Chippewa Sewer Authority which includes how much we are charged per gallon and the processing cost for said gallons. He is also going to request an accounting of how many gallons are processed daily. Mr. Bradow feels we are being over charged as the monthly bill does not reflect our actual usage. Additionally, Mr. Bradow will be visiting New Brighton to determine how they implemented the Tax Relief for Volunteer Firefighters, and whether it has increases the number of volunteers, and if it has improved services, he will return to the board and make a recommendation on whether it would be beneficial for the Township to implement. Finally, Mr. Bradow will visit with the Police Chief and the Fire Chief to discuss if Patterson Township is in need of any Crowd Control Policy, similar to that which the City of Pittsburgh has he will report to the board his findings next month.

- Mr. Mahosky supplied additional employee evaluation forms for the Board to review and discuss at the monthly meeting in May.
- Mr. Policaro brought up a memo from the Township Secretary to move funds from the General Fund to the PLGIT Investment fund and opened this for discussion. Mr. Mahosky asked for clarification on investment options and it was discussed to move \$150,000.00 to the Prime PLGIT Account and to move \$250,000.00 to the PLGIT Term rate through August 2019. Mr. Policaro advised this will need to be raised for a vote at the regular meeting. Mr. Mahosky will raise a motion during the regular meeting to move the funds.
- Mr. Inman advised that Mr. Yonkee will be attending the meeting to request action be taken by the Board to urge Blackhawk School District to keep Patterson Township School open. Discussion was raised as to the specifics of Blackhawks plans, other than those listed in the Beaver County Times Newspaper article. Mr. Inman believes that without the School the property values will decrease. Mr. Policaro countered by asking if the Board as a whole has enough information regarding this matter to take action at this time. This matter was tabled for discussion at the next meeting.
